

**LAY'S® SOCCER VICTORY SWEEPSTAKES AT PRICE CHOPPER ("SWEEPSTAKES")
OFFICIAL RULES**

THIS SWEEPSTAKES IS ONLY OPEN TO LEGAL U.S. RESIDENTS OF KANSAS AND MISSOURI, WHO ARE EIGHTEEN (18) YEARS OR OLDER AT THE TIME OF PARTICIPATION.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. MESSAGE AND DATA RATES MAY APPLY IF ENTERING VIA TEXT MESSAGE. INTERNET ACCESS REQUIRED TO PARTICIPATE VIA EMAIL OR WEBSITE.

BY ENTERING, ENTRANT AGREES TO BE BOUND BY THESE OFFICIAL RULES AND THE DECISIONS OF THE SPONSOR (DEFINED BELOW), WHICH SHALL BE FINAL AND BINDING IN ALL RESPECTS. ANY DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

1. ELIGIBILITY: The Sweepstakes is open only to legal U.S. residents residing in Kansas and Missouri, who are eighteen (18) years of age or older with a valid US driver's license or government issued photo ID at the time of entry. The following persons are not eligible to enter or win a prize: employees, contractors, directors and officers of Frito-Lay, Inc. 2. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:00:00 p.m. (noon) Central Time ("CT") on April 27, 2026 and ends at 11:59:59 p.m. CT on June 1, 2026 ("Sweepstakes Period"). The time clock of the computer administering this Sweepstakes is the official clock for this Sweepstakes.

3. HOW TO ENTER: During the Sweepstakes Period, there are three (3) ways to enter the Sweepstakes as described below.

(a) TEXT MESSAGE:

(i) During the Sweepstakes Period, use your SMS-enabled mobile phone to text **VICTORY** to 86261. You will receive a reply text message from the Sponsor containing a link to an online entry form. Click on that link and then follow the online instructions to complete and submit the online entry form.

(ii) During the Sweepstakes Period, use your SMS-enabled mobile phone with camera feature to scan the code on Sweepstakes advertising materials by centering the code in the camera. Once completed, the code automatically opens the default messaging app on your mobile phone with the Short Code 86261 and the message **VICTORY** ready to be sent. Once you text **VICTORY** to 86261, you will receive a reply text message from the Sponsor containing a link to an online entry form. Click on that link and then follow the online instructions to complete and submit the online entry form. An entrant cannot participate solely by scanning the code.

By texting **VICTORY**, you acknowledge you will receive up to four (4) reply text messages about the Sweepstakes from the Sponsor, via automatic dialing system. (b) EMAIL: To enter without sending a text message, email pricechoppersoccersweeps@propac.agency with "Sweepstakes Entry" stated in the Subject line. In the body of the email, include your first and last name, complete mailing address (no PO Boxes), daytime phone number, date of birth, and email address. Email entries that do not contain all the required information will be disqualified. If entering with a mobile phone or other web-enabled device and using your wireless carrier's network, standard data charges from your wireless carrier may apply. Check with your wireless service provider for details on these and any other applicable charges. Entrants are solely responsible for any such wireless charges. 5. PRIZE DETAILS: One (1) Prize: Four (4) tickets to the FIFA World Cup 2026™ match scheduled to take place on June 27, 2026 in Kansas City, Missouri ("Match"). Prize conditions below apply. Approximate Retail Value ("ARV") of all tickets in this prize: \$2,320.00 (\$580.00/ticket).

Prize Conditions: Transportation, accommodations, parking, meals, gratuities, souvenirs, and all other expenses not specified herein are solely the winner's responsibility. If the winner is unable to attend the Match, the prize will be forfeited and Sponsor shall have no further obligation to winner. 6. WINNER NOTIFICATION: The potential winner will be notified by the Administrator, via email, and will be required to respond to the email within forty-eight (48) hours. For clarity, the forty-eight (48) hours begins at the time the email was sent by the Administrator. If a valid response is not received within the allotted time, the prize will be forfeited and an alternate

potential winner will be randomly selected (time permitting), in Sponsor's sole discretion. If an in-person hearing is required, then it will take place in the State of Texas. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including

any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Texas. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing).
